ENTRY FEE: For Tracking Dog - \$60.00 for Tracking Dog Excellent - \$100. A recording fee of \$.50 AKC Recording Fee plu \$3.00 AKC Event Service Fee are included in each entry and will be forwarded to AKC per Chapter 11, Section 2 of the AKC Rules. ELIGIBILITY: *Tracking Dog* - Dogs holding the title of Tracking Dog shall not be barred from participation in this test; however the Test Secretary shall give priority to entries for dogs that do not hold the TD title. Entries are limited to 8 Dogs. Dachshunds have priority in the draw. Any remaining tracks will be selected from other AKC breeds.

*Tracking Dog Excellent* - Dogs holding the title of Tracking Dog Excellent shall not be barred from participation in this test; however the Test Secretary shall give priority to entries for dogs that do not hold the TDX title. Entries are limited to dogs 2. Dachshunds have priority in the draw. Any remaining tracks will be selected from other AKC breeds.

BITCHES IN SEASON: Bitches in season may participate in this test with prior notice to the Test Secretary and provided that all provisions of Chapter 2, Section 8 of the AKC Tracking Regulations are complied with.

DRAWING: A random draw for entries and alternate list will be held on Friday, January 10, 2014, at 7:00 pm. At Pete's – Bay Meadows 1020 Park Place, San Mateo, CA 94403 Phone 650-403-0110.

ALTERNATE LIST: An alternate list shall be maintained and will consist of entries received by the closing date, but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for the limited entries.

CERTIFICATION: With each entry of a dog that has not passed an AKC Tracking test, there must be filed an original statement, dated within one year, signed by a person who has been approved by the AKC to judge a Tracking Test, certifying that the dog is considered by him or her to be ready for such a test.

NOTIFICATION: The results of the draw will be sent as soon as possible following the draw. Should such notification not be received by the exhibitor within a reasonable time, please notify the Test Secretary.

DRAWING FOR RUNNING ORDER: All dogs and handlers must be at the test area by 8:00 am Monday January 20, 2014, at which time there will be a drawing to determine running order. Entrants not present at the time of the drawing will be marked absent and an alternate will be allowed to run in their place.

JUDGING: Judging will begin as soon as the tracks have aged sufficiently.

AWARDS: An award will be offered to each dog passing the test.
