Directions: Turn right leaving grounds. Turn LEFT onto BRANDT. Turn LEFT onto STANLEY AVE. Merge onto OH-4 S toward MIDDLETOWN/I-75. Merge onto I-75 S toward CINCINNATI. Take the Dryden Rd. South exit toward Moraine. At the bottom of the ramp turn RIGHT onto SPRINGBORO RD WEST. Turn left at the first light after passing under I-75. Clinic will be on the left.

ORDER OF JUDGING

The grounds will open at 7:30 am EDT Saturday, April 28. **Test 1** Masters brace draw will be held at 8:45 am, briefing and judging will follow. Introduction to Quarry will begin at 10:30 am if Master has concluded. Senior judging will begin approximately ½ hour after the conclusion of Master. Junior judging will begin approximately ½ hour after the conclusion of IQ. **Test 2** will follow ½ hour after the conclusion of Test 1. The Earthdog Test Committee reserves the right to make changes to the running order to expedite this event. **Entrants should check the gate sheets for running order.**

NOTICE TO EXHIBITORS

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules on the Official AKC Entry Forms are **NOT ACCEPTABLE**. Unsigned entries or entries with missing information other than the dog's call name will be returned.

TELEPHONE, FAXED, INCOMPLETE AND UNSIGNED ENTRIES cannot be accepted.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after trial has closed.

ENTRY FEES AND ALL OTHER FEES MUST BE PAID IN U.S. FUNDS. No Canadian checks.

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

RETURNED CHECKS do not constitute a valid entry fee. A charge of no less than \$25.00 will be made for each returned check.

NO ENTRY SHALL BE MADE, AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE: Express mail entries must include signature permitting them to be left at the secretary's address without the recipient's signature. **The owner or handler entering a dog in these tests does so at his or her own risk** and agrees to assume responsibility for any damage caused by him/her or by his/her dog. He/she also agrees to abide by all rules set forth in this premium list.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. No entry fees will be returned if the test cannot start or be completed due to an act of God or any cause beyond the control of the Test Committee.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. The owner of each dog is solely responsible for having it ready when it is to be judged. The club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not in the holding area when required. If handlers have a conflict and so inform the gate steward, every effort will be made to accommodate them.

CODC, DCA, GCAC will NOT be responsible for any accidental injury or loss to participants, their dogs, or property while participating in these events.

DOGS MUST BE AT LEAST 6 MONTHS OLD. AKC registered dogs, dogs with ILP or PAL numbers of eligible breeds that are spayed or neutered or have a Limited Registration may participate. Only completed entry forms, including Registration, ILP or PAL numbers will be accepted.

BITCHES IN SEASON ARE NOT ELIGIBLE FOR ENTRY. Entry fees paid for a bitch that comes into season will not be refunded.

NO DOG shall be allowed inside the test area until his or her judging time OR within 100 feet of test areas while classes are being run.

EXCESSIVE BARKING will result in exhibitors being asked to quiet their dogs. Repeated requests to control barking may result in the exhibitor being asked to leave the grounds.

SPECTATORS shall be allowed outside the test area provided that they are quiet and do not distract the dogs.

ALL DOGS are to be on leash or confined to exercise pens while on the test grounds. Please be considerate of others when setting up ex-pens. Space should be condensed as much as possible. You may be asked to reduce the number or size of your pens.

Those staying in area motels: Most earthdog competitors are model guests, but it is becoming increasingly difficult to find motels that will accept dogs due to bad experiences with excessive barking and failure to clean up after dogs. Please make it possible to have tests in the future. **Never leave your dog(s) unattended in a motel room and please clean up after them.** Your entry in future tests may be affected by failure to abide by these rules.

TEST SITE AND FACILITIES

Gem City Agility Club grounds is a completely fenced 10-acre site. There will be port-a-lets available. The first building (named the Faulkner Bldg.) is designated for registration and administration. Awards ceremonies will take place outside this area. There is no space for crating, so please be prepared to crate inside your vehicle, or use ex-pens. All parking will be in the field adjacent to the small fenced ring and next to the roped off test area. Test committee members and judges will be permitted to park along the driveway in designated areas. There will be adequate trash cans located throughout the area, so please remember to pick up after your dogs. Please pick up any trash and dispose of it in the cans as well.

GROUNDS AVAILABILITY

The grounds will be available after 12:00 pm EDT Friday, April 27, 2018. The gates will be closed for security reasons at 8:00 pm unless prior arrangements are made.

RV/CAMPING

Self-contained RVs and tent/vehicle campers are permitted. Parking will be available adjacent to small fenced agility ring. No dog/handlers will be permitted in the agility ring. Anyone dumping on the grounds will be asked to leave and no refund will be given. Fee is \$10.00 per night.

No Electrical Hook-ups are available. Judges and committee members will have a designated parking area next to the Registration building.

**Generator noise and exhaust must be vented away from dogs
and other campers.**

Quiet hours 11:00 pm to 6:30 am must be observed.

Bring water, shade and shelter for you and your dogs. These tests will be run rain or shine.

A light breakfast and lunch will be available for a nominal fee.

From the North, South, or West: I-75 to Exit 56A Stanley Ave. exit (Exit 56A), turn east. From light #1 (Webster St. – Shell gas station) go 4 more lights to Brandt Pike (1.2 miles). Turn left (north) for slightly less than 1 mile. Look for Midwest Trailer Sales on the right. Turn right immediately afterward onto Valleycrest Dr. Gem City Agility Club is on the left behind a chain link fence before the residential area. (Note: Possible construction on I-75; check ODOT.org for updated closings.) From I-70 westbound, exit south on State Rt. 4 to Stanley Ave. exit, turn right, go to Brandt Pike, turn right, follow rest of directions above.
