

Directions to Northern Illinois Brace Club in Roscoe, Illinois

From I-39 /I-90 , go to Rockton Road (Exit #3). Go East on Rockton Road to County Line Road (second stop sign). Take County Line Road South to Elevator Road (first stop sign). Go West on Elevator Road .3 miles. NIBC will be on the North side of Elevator Road.

From I-43 go to Highway 140 (Exit #6). Go South on Highway 140. After about 5 miles Highway 140 curves at the State Line and becomes Highway 76. Continue for 4.5 miles to Hunter Road. Take Hunter Road to the West (right) for about 6 miles to NIBC on the North side of Elevator Road (Hunter Road becomes Elevator Road at the County Line .3 miles before NIBC).



CHICAGO BYPASS: From the East, take I-80 along the south side of Chicago until you are well past Chicago, then head north on I-355. YOU MUST EXIT I-355 at I-88 West or you will end up back on I-90! Take I-88 West to I-39, just a bit south of Rockford. When you get to Rockford you can follow our normal directions or trust your GPS.

ELIGIBILITY OF DOGS: Dogs six months of age or older and registered with the American Kennel Club are eligible to participate in earthdog tests, as are spayed and neutered dogs and dogs with Limited Registration provided they are classified as eligible breeds. Dogs of an eligible breed that have been granted an Indefinite Listing Privileges (ILP) or a Purebred Alternative Listing (PAL) are eligible to participate. A dog of an eligible breed with an acceptable foreign registration number is eligible to participate subject to Chapter 11, Section 1 of the Dog Show Rules. Bitches in season are not allowed. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Please be ready to show proof of Rabies vaccination. The following breeds are classified as eligible to participate in earthdog tests: Dachshunds, Miniature Pinschers, Miniature Schnauzers, and the following Terriers: Australian, Bedlington, Border, Cairn, Cesky, Dandie Dinmont, Fox (Smooth and Wirehaired), Glen of Imaal, Lakeland, Manchester, Miniature Bull, Norfolk, Norwich, Parson Russell, Rat, Russell, Scottish, Sealyham, Silky, Skye, Welsh, West Highland White and Yorkshire. Dogs that are blind or deaf shall not be eligible. Dogs may enter more than one regular class at an Earthdog test provided the dog is eligible for the class. The Senior Earthdog class is open only to dogs that have acquired the Junior Earthdog title prior to the closing of entries. The Master Earthdog class is open only to dogs that have acquired the Senior Earthdog title before the closing of entries. Bitches in season shall not be eligible to enter the test. Entry fees paid for a bitch that comes into season shall not be refunded. Should the committee or the Judge deem conditions are unsafe to run or continue the test, no refund of entry fees will be made. RULES AND ADDITIONAL INFORMATION

APPRENTICES. There will be no apprentice judging for the DCA National Earthdog test.

CAMPING. Overnight camping is available at the grounds.

Reservations must include payment and must be received by April 1st. REQUESTS FOR CAMPING SPACE MADE AFTER April 1st MUST BE MADE BY EMAIL OR TELEPHONE WITH CHERI FAUST AND WILL NOT BE ACCEPTED VIA US MAIL. Judges, Event Chairs and Secretaries will be considered first, and requests for all event days may be given priority over shorter stays. Reservations that cannot be accommodated will be refunded/returned. Cancellations received before April 1st will be refunded. Cancellations after April 1st will receive a refund less one day's reservation fee. Early departures will not receive a refund. The CAMPING RESERVATION REQUEST FORM is in the premium list. Please note that clubhouse "camping" is not available for these trials.

CAMPERS MAY NOT ARRIVE OR DEPART during quiet hours (10:00 pm – 7:00 am) except in an emergency situation.

Camper parking spaces will be assigned by April 8th via email. Spaces may not be shared, exchanged or otherwise changed without permission.

A shower is available in the clubhouse and will be available from 30 minutes after the conclusion of awards until 7:00 a.m. each day. Bring your own towels.

EARLY ARRIVAL (prior to noon on Monday 4/13) AND LATE DEPARTURES (after noon on Thursday 4/16) are possible, but must be arranged in advance with Cheri Faust.

Camping spaces will be marked and your camping unit and any vehicles are limited to your space or must be parked elsewhere. Please plan accordingly.

CLUBHOUSE. No dogs allowed in the clubhouse, except for awards. Washing dog dishes in the kitchen sink of the clubhouse is not allowed – please use the outdoor sink (preferred) or the bathroom sink, if necessary.

ENTRIES. Pre-entry will not be accepted for these tests. Entry forms must be complete, legible and submitted on a regulation 5 ½" x 8 ½" form. A separate entry form must be submitted for each dog for each class entered each day. Please make checks payable for entry fees to "Dachshund Club of America" or DCA.

FOOD. Continental breakfast and Lunch will be available for the judges each day of the tests. Exhibitors may visit any of the local eating establishments in Roscoe or Rockford. No food will be available for purchase at these events.

MOTORIZED VEHICLES. Golf carts and utility vehicles may be utilized during the tests. See "allowable drive area" map in the premium list.

MOVE UPS. Move ups will be honored for these tests.

NOISE. This is a residential area and respect for others in the area is required for use of these grounds. The barking of dogs must be kept under control at all times. Dogs may not be left unsupervised in x-pens. "Quiet hours" are from 10:00 p.m. until 7:00 a.m. During quiet hours the use of outside lights and noise must be kept to a minimum.

NO SMOKING. Smoking is prohibited on the NIBC and Garard properties, including in the clubhouse, parking/camping areas and on the running grounds at all times.

PRACTICE. There will be no practice in the rabbit enclosure for this event. The exception to this rule is handlers with paid annual running grounds privileges. To request a day pass for running ground privileges, contact Cheri Faust or other NIBC officers. No earthdog practice will be offered.
