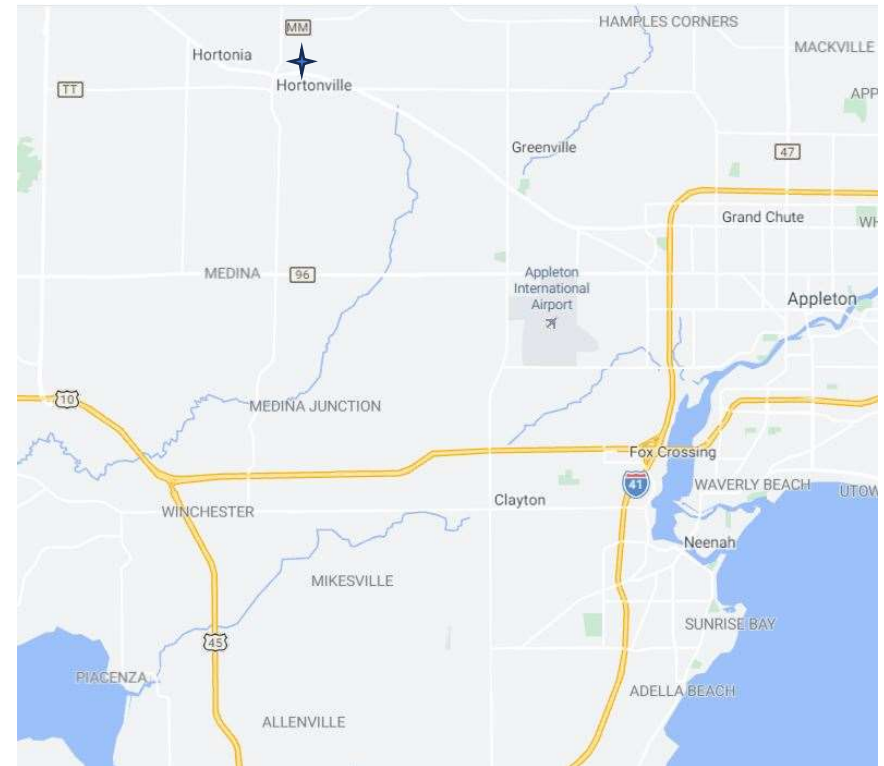

Directions to Fox River Beagle Club, Hortonville, Wisconsin

From I-39 /I-90, Take the exit for US-151 N toward Sun Prairie. Then take exit 148 for WI-26 N toward Rosendale/Oshkosh. Turn onto the US-41N ramp and then take exit 120 for US-45N toward US-10W/New London. Merge onto US-10W/US-45N. Take exit 273 for US-45N toward New London. Turn onto WI-96 E/Wisconsin Ave. Turn left onto County Rd T. Turn L onto Baler Rd and the FRBC is 0.6 miles down the road on the right.

CHICAGO BYPASS: From the East, take I-80 along the south side of Chicago until you are well past Chicago, then head north on I-355. YOU MUST EXIT I-355 at I-88 West or you will end up back on I-90. Take I-88 West to I-39, just a bit south of Rockford. When you get to Rockford you can follow the directions above.

RULES AND ADDITIONAL INFORMATION

ABSOLUTE. There will be Absolute runs for each of these trials as listed on the page with the judging panel.

ALCOHOL. Badger Dachshund Club and Dachshund Club of America prohibit the consumption of alcohol on the trial grounds during the running of these trials. Trials are not considered to be over until the completion of the daily awards ceremony.

APPRENTICE JUDGES. There will be no Apprentice judging during the National Field Trial, but anyone interested in apprentice judging during the host club events should contact the Event Chair or Secretary for the day to discuss availability and options.

CAMPING. Overnight camping is available at the grounds in a limited capacity. There is no water or sewer connection available, but there is a hose that can be used to fill tanks with potable water. There is no sewer dump station on site. Judges have first priority for reservations. All campers are liable for any damages they may cause to the grounds to include holes dug in the grass by dogs or vehicles. For damages not repaired, the responsible party will pay a fee to the Fox River Beagle Club commensurate with the repairs required to leave the site as good as or better than it was prior to arrival and fees will start at \$50.00. Failure to pay for damages may result in revocation of camping privileges. Campers may arrive after noon on Tuesday. No arrivals after sunset. Space will be extremely limited so all vehicles and campers must be kept within your assigned camping space.

Please note that clubhouse “camping” is not available for these trials.

Showers are available in the clubhouse and will be available from 30 minutes after the conclusion of awards until 6:30 a.m. each day. Bring your own towel and shower supplies. Please take them with you when you are done showering.

CLUBHOUSE. No dogs allowed in the clubhouse except for awards.

DAY PARKING. Day parking will be located on the south side of Baler Road directly across from the clubhouse. There will be no overnight camping in the Day Parking Lot. Drivers are responsible for any damage to the ground (such as holes or tire ruts). If your vehicle needs to be towed, you will be responsible for your own towing.

ENTRIES. Pre-entry will not be accepted for these trials. Entry forms must be complete, legible and submitted on a regulation 5 ½” x 8 ½” form. A separate entry form must be submitted for each dog for each trial entered.

FIELD MARSHALS. If you are willing to marshal, please let the FT Chair, Secretary or Cheri Faust know what stake(s) will work for you. Marshals will be confirmed day-of-trial.

FOOD. Members of the Fox River Beagle Club will be preparing breakfast and lunch at these trials. If you have special needs/diet requirements, please plan accordingly. Payment for all meals will be made to Badger DC. Payment for meal reservations is expected by April 8, 2026 and you will be provided with your meal tickets on arrival.

Meals will be available for purchase by reservation. The welcome dinner on April 8, 2026 will be complimentary Root Beer floats with Illi Dachshunds Root Beer and ice cream and will be held at the FRBC clubhouse. There will also be brats and burger with sides. Please join us for dinner and shared camaraderie.

The Performance Awards Dinner will be held on April 9, 2026 after completion of the field trial and awards. The Awards Dinner will be held at the Fox River Beagle Club and will be catered by Mike Kingsland of the Fox River Beagle Club. Cost to attend is \$25.00

HARNESSES. AKC rules are silent regarding the use of body harnesses. As a result, body harnesses will only be allowed if the handler receives advance permission of both judges for the class. Harness must be well fitting with nothing hanging from it and with no attachments other than tags for identification purposes. The harness must remain on the dog the entire time the dog is under judgment.

MOTORIZED VEHICLES. Golf carts and utility vehicles may be utilized during the trial with limited drive areas. The golf cart driver is responsible for any damages to persons or property as a result of golf cart use.

NOISE. Please be respectful to other exhibitors. Dogs may not be left unsupervised in x-pens. If a large generator is used, you will be required to move it far enough away from the campsites that the noise will not disturb other campers. Quiet hours are from 10pm-5am.

NO SMOKING. Smoking and vaping are prohibited in the clubhouse and the running grounds at all times.

PRACTICE. Practice will be allowed on Tuesday after 2pm and Wednesday after completion of the national field trial, but practice will not be allowed after the conclusion of the remaining days’ events. Practice is limited to one dog at a time per person. Do not arrive before 2pm for practice on Tuesday.

RETURNED CHECK FEE. Any check issued to Badger Dachshund Club that is returned for insufficient funds will be subject to a \$35.00 penalty payment in addition to the actual amount of the check. Failure to redeem returned checks will result in being placed on a “cash only” basis, and may be reported to AKC as an unpaid entry.

STEWARDS OF CHILDREN. The AKC is committed to creating a safe and respectful sport environment for all. If you need to talk to someone, or need help, please call 800-656-HOPE (National Sexual Assault Hotline) or text HOME to 741-741 for free 24/7 confidential services from trained crisis counselors.

TRACKING COLLARS. GPS or other tracking collars will be permitted during these trials. The collar surface against the dog’s neck shall be flat with no protrusions. While the dogs are under judgement, the handheld devices must be turned off. Handheld devices may be turned on only after the dachshund has been eliminated from competition by the judges or judgement has ceased. In accordance with AKC rules, special training devices that are used to control and train dogs, including but not limited to, collars with prongs, electronic collars used with transmitters, muzzles and head collars may not be used on dogs at AKC events, except as allowed in the AKC Rules, Regulations, and policies.

TRASH. There will be a dumpster for your trash. Please keep your camping and day parking areas clean. Pick up after your dogs and do not leave trash (baggies, water bottles, etc) in the field trial grounds.. Always leave a site better than you found it.

BUT WAIT, THERE'S MORE!

Following the field trial, there will be one travel day to allow exhibitors time to move to the Northern Illinois Brace Club in Roscoe, IL for 2 days of earthdog tests. The DCA National Earthdog Test will be held April 14, 2026 and there will be a DCA Earthdog test on April 15, 2026.
